***Update* Bank Robbery in Wallingford**

On April 2nd, 2024, Wallingford Police arrested a father and son duo for their connection to last week's bank robbery in Wallingford. 28-year-old Matthew Kevorkian of 147 Lyons Street #3, New Britain, CT and 68-year-old Mark Kevorkian of 14 Concord Street C1, West Hartford, CT were both arrested and charged with violation of Connecticut General Statutes 53a-48/53a-135- Conspiracy to Commit Robbery 2nd Degree, 53a-48/53a-125- Conspiracy to Commit Larceny 4th Degree, 53a-125- Larceny 4th Degree, and 53a-135- Robbery 2nd Degree. Mark is being held on a \$50,000.00 surety bond and will be arraigned on April 3, 2024 at G. A. #7 in Meriden. Matthew was released on a \$50,000.00 surety bond and will be due in court on April 16, 2024 at 9:00 AM at G.A. #7 in Meriden.

On March 27 2024, around 12:25 PM, Wallingford Police responded to TD Bank (928 North Colony Road) for a reported bank robbery that had just occurred. The suspect fled the scene in a dark colored, four-door, Honda Civic. Staff at the bank reported the male suspect passed a note to a bank teller demanding cash, and said he left the bank and entered a dark colored Honda Civic. Staff at the bank said he made off with an undetermined amount of cash and that no weapon was used during the theft. Officers descended upon the area immediately and initiated their investigation into the incident. We determined there was another person in the getaway car.

Shortly after the incident, Newington Police discovered the Honda Civic in their town, used stop sticks to try to stop the car, but the suspects fled. The Honda Civic was later discovered at JC Penny at 1339 Tolland Turnpike in Manchester. Wallingford Detectives worked with numerous other law enforcement agencies and quickly identified Matthew and Mark Kevorkian as the suspects. Detectives filed arrest warrants for both and arrested them at an address in New Britain on April 2, 2024.

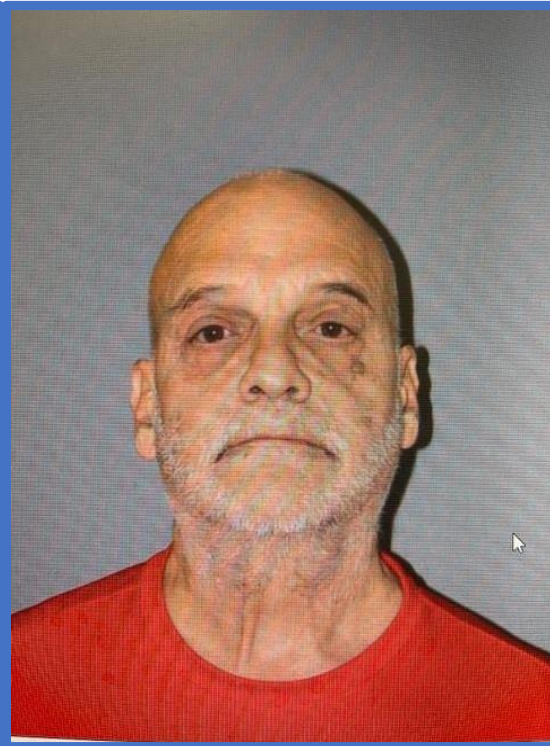
