### Drugs and Firearm Found During Motor Vehicle Stop

On April 7, 2023, at 11:18 pm, a gray 2004 Oldsmobile Alero was observed traveling eastbound on Old Colony Road, displaying no rear license plate. A motor vehicle stop was conducted for the violation and during the stop it was revealed that the Oldsmobile had a misuse registration number written on cardboard and positioned in the back window. The Oldsmobile was not registered nor insured and the male driver did not have a license. The driver was arrested and placed into handcuffs but appeared to be hiding something in his waist band. The driver was concealing approximately 7.2 grams of crack cocaine, in two plastic bags with multiple prepackaged baggies for street level resale. The driver also had \$495.00 cash, and during a search of the Oldsmobile it was discovered that the driver was in possession of a "MOD GT 27-CAL..25 AUTO" pistol style firearm and drug paraphernalia.

The male was identified as 38-year-old Sinclair Lesean Humphrey of 32 East Ferry Street, New Haven CT. Humphrey was charged with violation of Connecticut General Statutes 53a-217c-Criminal Possession of a firearm , 29-35 Carrying a pistol without a permit, 21a-277(a) Sale of a narcotic substance, 29-38 Weapon in a MV, 21a-267(a) Drug paraphernalia, 14-147(c) Misuse of marker plates, 14-12(a)\* Unregistered MV, 14-18 Failure to display, 14-36(a) Operation of a MV without a license, 14-213b Operation of MV without insurance, and 14-230(a) Failure to drive right. He was held on a \$25,000.00 Surety Bond.
