### Violent Domestic Violence Arrest

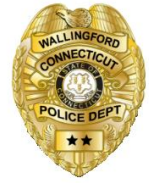
On January 25, 2023 around 9:35PM, Wallingford Police responded to a domestic violence call. The victim had visible injuries and after a preliminary investigation, it was also determined to be a violent sexual assault that occurred in the presence of a minor. With the assistance of the Detective Division and the Community Impact Unit seamlessly working together the suspect Mark Anthony Lincoln (DOB 12/12/1998), was located and taken into custody.

Lincoln was arrested for violation of Connecticut General Statutes 53a-64bb Strangulation 2<sup>nd</sup> Degree, 53a-62 Threatening 2<sup>nd</sup> Degree, 53a-63 Reckless Endangerment 1<sup>st</sup> Degree, 53a-61 Assault 3<sup>rd</sup> Degree, 53a-95 Unlawful Restraint 1<sup>st</sup> Degree, and 53-21 Risk of Injury. Lincoln was released after posting a \$100,000 surety bond and was issued two separate Conditions of Release. Lincoln was given a court date of January 26, 2023 to appear at the Superior Court, in Meriden at 9am. Wallingford Police Department Case Number 23-2201.

On January 26, 2023 Lincoln was arrested once again after he violated two counts of Connecticut General Statute 53a-222 Conditions of Release. Lincoln violated the Conditions of Release prior to his court appearance on January 26, 2023 after midnight. Lincoln was given another court date of January 27, 2023 to appear at the Superior Court, in Meriden at 9am. Wallingford Police Department Case Number 22-2309.
