Car Break-ins Interrupted and Two Arrests Made

On 11-16-21 around 2:45AM, Wallingford Police officers went to Parker Place Apartments (53 Parker Street, Wallingford, CT) to investigate possible car break-ins in the area. The investigation led to the arrest of 22 year-old Gary Gibson of 17 Beacon Avenue, New Haven, CT and 22 year-old Justin Miller of 25 Collins Drive, West Haven, CT.

A witness initially called the police and said two people were trying to open a number of car door handles in the apartment parking lot. When officers showed up, they immediately located and detained Miller in the area of Washington Street near its intersection with Parker Street who was wearing all black clothing, a black face mask and purple latex gloves. Officers then found Gibson who evaded officers on foot. Gibson was apprehended after a foot chase by Wallingford patrol officers. Gibson was also wearing all black and purple latex gloves.

Through investigation, officers determined that Miller and Gibson were using a stolen Alfa Romeo out of Milford, CT to commit the thefts. After a vehicle search, officer located a number of other items stolen from other vehicles in Wallingford and other jurisdictions.

Both Gibson and Miller were arrested and transported to Wallingford Police Headquarters for processing.
