Peeping Tom Arrested in Wallingford

On January 19, 2022, 40-year-old Craige Stephens of 48 Lincoln Street in New Britain, Connecticut was arrested by warrant. Stephens was charged with violation of Connecticut General Statutes 53a-189a(a)(3)-Voyeurism, 53a-182- Disorderly Conduct, and 53a-109-Criminal Trespass Third Degree. He was released on a \$25,000 surety bond and is due in court on March 2, 2022 at G.A. #7 in Meriden.

During 2020 and 2021, the Wallingford Police Department received numerous reports of a “peeping tom” in town who was looking into people’s windows. On July 23, 2021 during the night time hours, officers responded to the area of Clifton Street for the report of a person outside of a victim’s window in the back yard. The victim reported that they saw someone looking through their window. Responding officers discovered concrete blocks stacked near the window where the victim saw the person. Officers located several pieces of evidence in the vicinity and the case was further investigated by the Wallingford Police Detective Division.

Wallingford Detectives completed a lengthy investigation involving several search warrants, and ultimately developed probable cause to arrest Stephens for the crime. Investigators additionally found that Canton Police previously arrested Stephens on October 5, 2021 for a similar instance.
