## **4 Arrested After Fleeing from Stolen Car Following Crash**

On May 2, 2022 around 1:45AM, East Windsor Police Department called the Wallingford Police Department looking for assistance in locating a stolen 2021 Ford Explorer Sport Limited from their town. They relayed they had reason to believe the car was located in the area of 1406 Durham Road in Wallingford. Wallingford Police officers converged on the neighborhood and the stolen car fled the scene. The stolen car ended up crashing off the roadway on Route 68 when it failed to negotiate the turn from High Hill Road.

Four individuals dressed all in black fled the accident scene on foot into the woods nearby. After officers searched the area for some time, they found the 4 suspects hiding behind a nearby residence. All four were arrested and transported to Wallingford Police headquarters for processing.

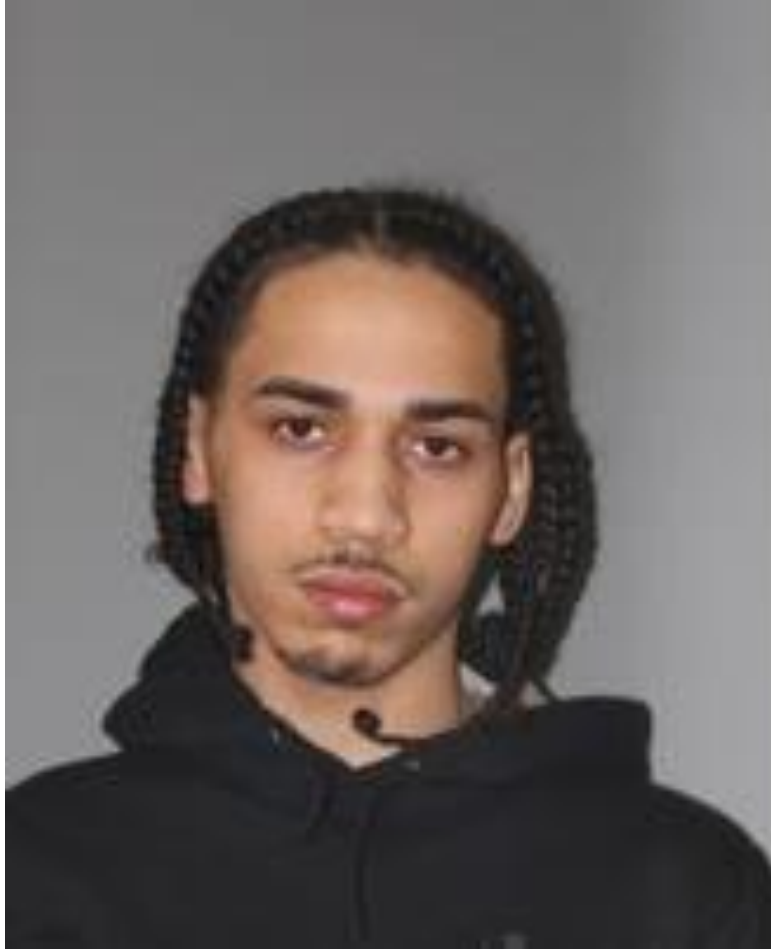
