Commercial Burglary Arrest:

On 2-6-2021 during the overnight hours, 36-year-old Daniel Girdzis of 154 Hemmingway Avenue, East Haven, CT and 35-year-old Adis Kacar of 578 Campbell Avenue, West Haven, CT were arrested and charged after a joint investigation into a string of commercial burglaries by members of the Wallingford Police Department, Guilford Police Department, and North Branford Police Department.

This arrest stems from a burglary that occurred at One Stop Liquor (1056 South Colony Road) on 2/6/2021 at approximately 0008 hours. On this date and time specified, Wallingford Police Officers responded to One Stop Liquor following a burglar alarm. Upon their arrival, Officers noticed the front window of the business was smashed out and confirmed that a burglary had just occurred.

After investigation, both suspects were located and taken into custody in New Haven shortly after the theft and were transported back to Wallingford Police Headquarters for processing. Through the investigative process, it was determined that Kacar had an additional outstanding Violation of Probation Warrant which was served at the time of his arrest. A small amount of a controlled substance was also found during the arrest process. The following is a summary of each arrestee's information and charges:
